


DataPort® 30 SATA-to-IDE Carrier Installation Guide

Prior to installing your hard disk drive in the DataPort 30 SATA-to-IDE carrier you must make sure the hard disk drive is jumpered as Single or Master. Consult your hard drive manual for details. If you install the hard drive jumpered as Cable Select or slave, it will not be detected on some computers.

Installation

1. Remove the screw that secures the top cover, then remove the top cover of the DataPort 30 carrier.
2. Connect the keyed data cable and then the power cable to the hard disk drive (see diagram).
3. Rotate the hard drive so the end with the data cable and power cable slides into the carrier first. Make sure that the data cable is looped up toward the top cover and folded over the top of the hard drive. Be careful not to pinch or damage the data cable.
4. Gently push the hard drive towards the back of the carrier until the front of the hard drive can be lowered into the carrier and the front side mounting holes align.
5. Secure the hard drive with the four screws provided.
6. Replace the top cover and insert the screw.
7. Insert the carrier into the DataPort 30 frame and turn the lock to secure the carrier and turn the power on.



Product Warranty
